EIGHT POINT WIND, LLC, a Delaware limited liability company, for itself or on behalf of an entity formed or to be formed (the "Company"), has submitted an application (the "Application") to the Agency, a copy of which is on file with the Agency, requesting the Agency's assistance with respect to a certain project (the "Project") consisting of: (i) the acquisition by the Agency of a leasehold interest (or other interest) in certain real property located in the Towns of Greenwood, West Union, Hartsville and Hornellsville, Steuben County, New York (the "Land"); (ii) the construction and equipping on the Land of an approximately 101.8MW wind generation facility consisting of approximately twenty-five (25) wind turbines, together with related substations, overhead and underground cabling and roadways for the production of wind-generated electricity and related improvements (the "Improvements"); and (iii) the acquisition of and installation in and around the Improvements of certain items of equipment and other tangible personal property (the "Equipment"; and, collectively with the Land and the Improvements, the "Facility").

The Agency will acquire a leasehold or other interest in the Facility and lease the Facility back to the Company. The Company will operate the Facility during the term of the lease. At the end of the lease term, the leasehold interests will be terminated. The Agency contemplates that it will provide financial assistance to the Company in the form of an exemption from New York State and local sales and use taxes and a mortgage recording tax exemption, consistent with the policies of the Agency, and a partial real property tax abatement structured within a payment-in-lieu-of-tax agreement (the "Financial Assistance").
